#### **1. Call to Order**

Mr. Wardle asked what impact social media is playing on kids who want to be liked on social media, asked if they see a big problem with students using social media to judge themselves, and wondered how that is addressed. Ms. Kraus said social media has some positive and some negative concerns such as anxiety, sleeplessness, and connectedness but said there are pros and cons to everything. She said we especially watch for this at the early high school and middle school level and stated that as students age, they are generally better adjusted and set boundaries on who they connect with but also said that as a District we continue to try to find ways to support our students.

Mr. Myers asked if all students are initially tested with Terrace Metrics and Dr. Leonard responded only with parent permission. Mr. Myers followed up by asking if students generally take the assessment seriously and Ms. Kraus stated there are built in validity measures such as the ability to see if a student took the assessment in 3 minutes which may indicate they didn't take it very seriously or had a dramatic change in response which also triggers a follow-up. Ms. Kraus also stated that overwhelmingly, she believes students take the assessment seriously and it provides enough information for counselors to engage in further conversations.

Mr. Over asked if the counselors and District staff have enough resources or have any needs and Dr. Leonard shared that we are still working to understand and learn more things about our students. She also stated the process is constantly evolving and reassured Mr. Over that we will ask the Board if we feel we need more support.

Dr. Roberts said Dr. Leonard and Ms. Kraus have been instrumental in building a support system which aspires to offer more opportunities to connect more students using a close partnership with families to work together and stated that we are seeing good results.

## **2.b. Virtual Tutoring - Mr. Bill August**

Mr. August presented a view of Virtual Tutoring to the Board:

Mr. Over asked about the screening process of the virtual tutors and Mr. August responded they are mostly doctoral students who are rigorously trained to tutor and said copies of tutoring sessions are maintained in folders in an effort to offer complete transparency. He also stated tutors are vetted by the company for appropriate clearances and compliance.

Mr. Piper asked if we contract with the virtual tutoring company and Mr. August responded yes.

Mrs. Webster asked if our students currently have access to this tutoring and Mr. August said we are piloting this but will be pushing it out to students in grades 5-12 and providing details and more information to both students and parents. Mrs. Webster asked if a student is constantly going back for help would the company notify their teacher and Mr. August said teachers can review the student tutor help sessions.

Mr. Over asked how much this costs and Mr. August reminded everyone this is paid by a grant at a cost of \$120,000 but stated we aren't committed to this in the future and can evaluate its success before moving forward.

Mr. Piper asked if we could track how many students are using this resource and Mr. August confirmed we can. Dr. Roberts stated our summer school program offers 16 instructional days for \$40 - \$45,000 but said this tutoring would be available to students during the entire school year.

Mr. Over asked when and how it will be shown to students and Mr. August shared that he met with building administrators and they will communicate to students and staff in each building but Mr. August will communicate with parents. Mr. Over suggested a demonstration be provided to each class.

Responding to a question from the audience about the location of the tutors and service, Mr. August stated he would have to double check if they are based entirely in the US.
