General Questions:

1. Mr. Barrick asked if the air ventilation unit was a roof top unit.
2. Mr. Wolf inquired about any long term issues if we choose not to replace all the piping.
3. Mr. Barrick questioned the life span of the air handlers.
4. Mr. Barrick asked if we would have to run the entire chiller just to keep the office area cool in the summer.
5. Mr. Fry inquired if the system would dehumidify twice.
6. Mr. Barrick questioned if the cabinets would be taken out or boxed out.
7. Mr. Fry asked if the air ventilation units would be invasive if we waited seven years from now.
8. Mr. Fry question if the air handlers could be a standalone item.
9. Mr. Fry asked if this will provide the pressurized system.
10. Mr. Kerr inquired if they could explain how the unit vents and this duplicate system is being created to interact.
11. Mr. Wolf questioned if the lights would be reduced to half.
