For the 2023-2024 school year, there are two important things that parents/guardians and students need to be aware of before the first day of school.

- There will not be a charge to students for breakfast again this year. One breakfast meal is available to each student each day.
- **2.** Eligible reduced students will not be charged for a lunch.
