II. DISCUSSION ITEMS

A. Review of 2019 Project List

Dr. Richard W. Fry, Superintendent of Schools reviewed the Project List for Mt. Rock Elementary School, Big Spring Middle School, Big Spring High School and Oak Flat Elementary School with the Board of School Directors.

2. Mr. Kanc commented on the HVAC system not being sized correctly at Oak Flat.
3. Mr. Blasco asked, who was the architect for Oak Flat Elementary School? Dr. Fry communicated that Hayes Large was the architect.
4. Dr. Fry commented that the District try's to keep cost down when Oak Flat Elementary School was built.

B. Director Updates

8. Dr. Fry updated the Board of School Directors on the geothermal leak. The fix for the leak will be under \$10,000.
