II. PRESENTATION

a. FFA Presentation

Emma communicated that Big Spring High School offers 15 agriculture courses. Emma shared that this past spring when students filled out their course selection sheets, there were over 570 requests. - Dr. Fry also shared that all other taxes outside of real estate Big Spring School District taxpayers are paying less, at 32% of taxable limit. The lowest percentage of rural districts in the area and in the ten best overall in the Capital Area Intermediate Unit.
- Dr. Fry stated that out of the state-wide rural districts Big Spring School District is doing quite well.
